

## **Governing Body's Annual Statement 2017/2018**

The Issues faced and addressed by the Governing Body over the last year were:

- ICT Support and Infrastructure – a new company was appointed to carry out ICT support and infrastructure, this followed a lengthy evaluation of the current provision and a detailed procurement exercise to make our decision. This change has resulted in significant financial efficiencies and improvement of our current ICT provision. School are already seeing improvements in system support and a much smoother running system, eradicating the negative impact on Teaching and Learning time.
- OPAL – Playtimes and the school outdoor environment have never been so good. A huge amount of work has gone into transforming the outdoor environment of the school. Staff training, parental involvement and most importantly children's play have resulted in Denbigh being awarded the Platinum OPAL award. This has had such a positive impact on the behaviour, wellbeing and confidence for the children and has also resulted in a reduction in challenging behaviour.
- Staff development – The Governors of Denbigh are committed to staff development, as a National Support School a member of staff from Denbigh has been seconded for 1 year into a senior leadership post to support another school with weaknesses in their management structure.
